## Investment Objective

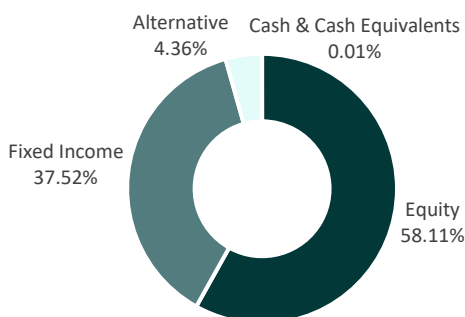
The investment objective of the Fund is to invest substantially all of its assets in Aditum Investment Funds - HCM Multi-Asset Moderate Fund (the "Master Fund"), a sub-fund of Aditum Investment Funds, a Luxembourg mutual fund (fonds commun de placement) qualifying as undertaking for collective investment in transferable securities (UCITS). The Master Fund is an actively managed fund-of-funds that seeks to deliver total return through capital appreciation, income accumulation over a mid to long-term investment horizon and through investing in a diversified range of assets in proportion with its long-term risk profile which is characterised as MEDIUM.

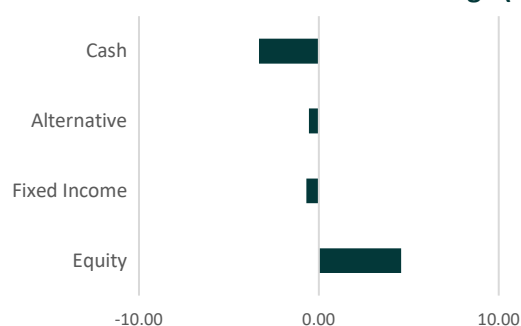

## Master Fund Tactical Allocation MoM Change (%)

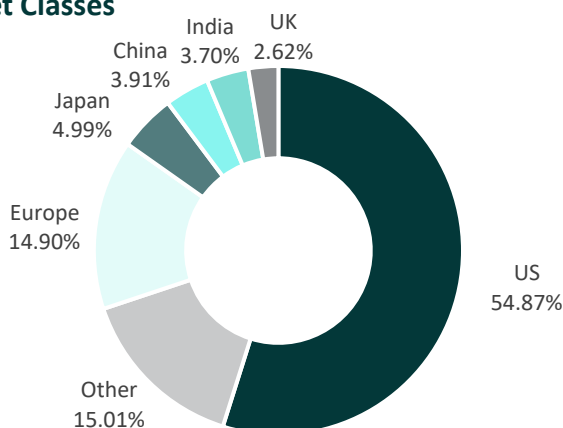

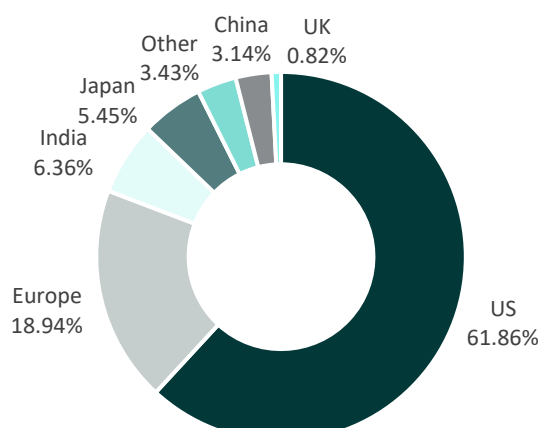
