INVESTMENT OBJECTIVES

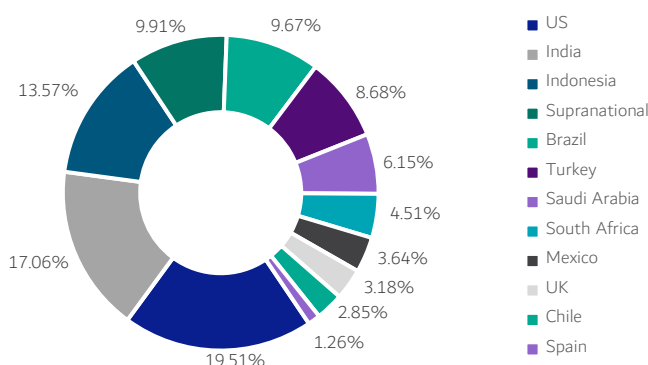

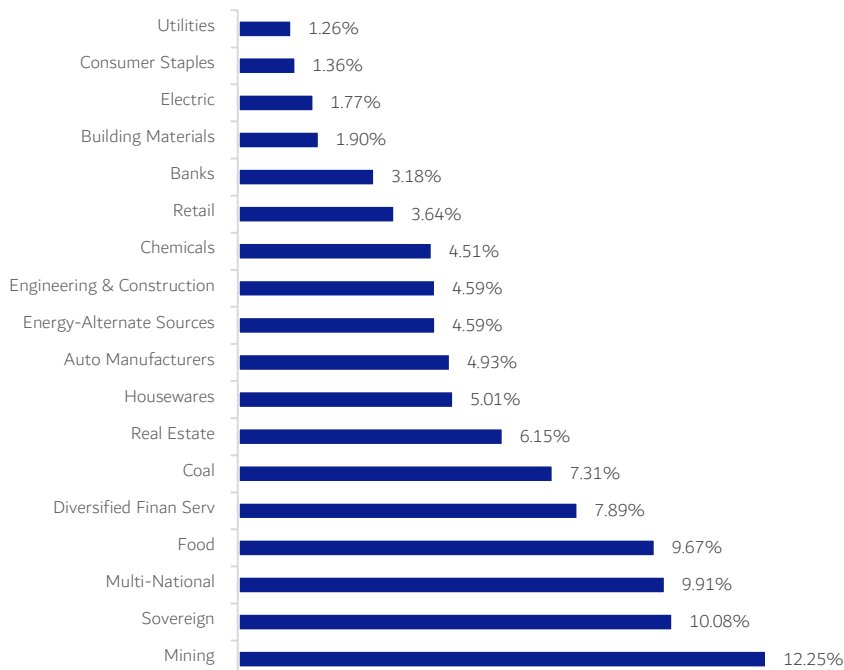
