

INVESTMENT OBJECTIVES

The Short Term Liquid Securities Fund GBP (the "Sub-Fund") is an actively managed fund that aims to provide liquidity and an attractive risk-adjusted rate of income relative to short-term interest rates, to the extent consistent with the preservation of capital. The Sub-Fund will invest in high quality, short-term fixed income securities and money market instruments, including government, quasi government and corporates issued primarily denominated in GBP or hedged back to GBP, including but not limited to bank certificate of deposits, commercial paper, corporate and sovereign variable and fixed rate bonds and floating rate notes.



ASSET ALLOCATION




