INVESTMENT OBJECTIVE

The Signature CIO Balanced Fund Open Ended IC PLC (the "Fund" or "Balanced Fund") is a feeder fund that seeks to achieve growth through capital appreciation and income accumulation over a mid to long-term investment horizon. The Fund will invest in the Amundi Asia Funds - Signature CIO Balanced Fund (the "Master Fund") which is managed by Amundi Asset Management. The Master Fund combines top-down macroeconomic views and bottom-up mutual funds and ETF selection from Standard Chartered's Chief Investment Officer ("CIO") and Investment Management Teams.






ASSET ALLOCATION*




FUND ASSET ALLOCATION*

MASTER FUND COMMENTARY

Fund Performance

The Signature CIO Balanced fund managed to turn in positive performance for January despite the volatility in financial markets amidst elevated geopolitical tensions.

Our overweight in Asia ex-Japan equities delivered gains and contributed to performance, while US equities though positive, lagged global peers. We continue to keep our overweight on US and Asia equities and adopt a barbell approach – staying engaged in growth sectors such as technology while building exposures in selected value/defensive sectors such as healthcare. In Fixed Income, our overweight in EM LCY bonds led returns, supported by a weaker dollar. Within Alternatives, our overweight in Gold contributed meaningfully as prices escalated to new highs – we also trimmed Gold timely back to TAA weight just before the sell-off at the end of the month.

Fund Positioning

Despite persistent geopolitical challenges, we continue to favour a pro-risk stance, supported by strong corporate earnings, especially in the transformative, AI-driven technology sector. However, ongoing weakness in the US dollar makes global diversification more compelling lending support to growing optimism that the market rally may continue to broaden in breadth. In fixed income, we remain overweight EM bonds (in both US and LCY) on improving fiscal trends, higher yield (relative to DM bonds) and a weaker USD outlook. We stay Overweight gold, given persistent diversification demand and its defensive attributes within multi-asset portfolios.

For opportunistic ideas, we have closed the trade on European banks, following the strong rally in European Financials over December/January as investors rotated into value regions/sectors on the back of attractive valuations. We also closed the trade on US Utilities as we see strong Q4 2025 earnings from the US technology sector, led by semiconductors and internet firms continuing to support equities.

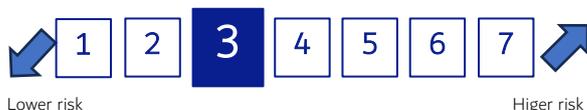
